I'm committed to steering Finestkind towards continued growth and success."

As Gus Dannoun from the Sydney Fish Market reflects, "from humble beginnings, Donna has built an enduring business based on her commitment to her fishers, supporting local packing houses, and delivering to market the best seafood products available."

Donna says Dan's arrival signals a new era for FinestKind.

"I will continue to be involved with Dan to ensure a successful transition and support its continued growth and success. I'm also planning to continue various industry memberships.

"I want to thank everyone for welcoming Dan as we transition into FinestKind NZ Limited trading as FinestKind.

"Creating the business has been a long rewarding journey. I am proud to have worked across the industry, supporting, and promoting independent fishers and the amazing people who work in it and to make a difference.

"I don't see myself as retiring yet, but I do have a bucket list that needs some attention."

As well as thanking Donna for her expertise and support, Dan has a thank you to extend to the wider FinestKind Whānau. "I want to express my gratitude to our customers and fishers. Your support is invaluable, and I'm committed to upholding FinestKind's reputation for quality and service excellence. After a recent visit to the Sydney Fish Market awards held on Sydney Harbour, Gus also likes what he sees.

"Although Donna is stepping down and moving on to the next chapter in her life, we're confident that with Dan at the helm, FinestKind, Sydney Fish Market, and its buyers, can look forward to working together for another successful 25 years, and beyond."

Meantime Dan and Donna can reassure customers that it is very much business as usual at FinestKind and the work of fishing, quota trading, exporting and seafood promotion will continue as it always has.
